

DAILY BLAST LIVE'S "MOTHER'S DAY BEACHES RESORTS VACATION GIVEAWAY" WATCH AND WIN OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. SUBJECT TO APPLICABLE FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.**

2. **Eligibility.** Subject to the additional restrictions below, DAILY BLAST LIVE'S "MOTHER'S DAY BEACHES RESORTS VACATION GIVEAWAY" WATCH AND WIN (the "**Sweepstakes**") is open to legal U.S. residents (excluding Puerto Rico, Rhode Island, New York, and Florida) who are 21 years or older at the time of entry. Exclusions: Telephone calls, Premium Wi-Fi, Red Lane® Spa treatments and services, specialty dining, tours & excursions, inter-island transportation, SCUBA certification courses, island departure taxes, personal charges, room service, purchases made at the Beaches Specialty Shops, baggage fees, customs duties and travel insurance **are not included**. Costs of meals outside of the designated resort, ground transportation other than local airport transfers on the island where the selected or designated resort is located, gratuities and taxes outside of the designated resort, transportation to and from airport of the winner’s residence and all other expenses not specified in these Rules as part of prize package are the sole responsibility of prizewinner.

COVID-19: A respiratory virus, called Covid19 and its variants have been identified as the cause of an outbreak of respiratory illness and cases have been identified in other countries and the Caribbean. Prior to entering the designated resort, all guests may be administered a no-touch thermal scan to screen for fever. Anyone with any fever ($\geq 38\text{ C}^\circ/100.4\text{ F}^\circ$) may not be allowed to enter the resort until they are assessed by a nurse or doctor. The medical professional may recommend that a COVID-19 test be administered. With a positive test result the guests remains isolated in their room until the release criteria of the specific jurisdiction is satisfied. If negative the guests will be free to enter and enjoy the resort. The Beaches Resorts reserve the right to implement other health, safety and COVID-19 protocols in its sole discretion. There is a risk in entry regardless of temperature checks, and all guests enter at their own risk and shall be advised as follows: *If you experience any symptoms of any illness while at the Resort, please stay in your room and contact the Medical Center. Consultation charges will be waived. If you develop symptoms after leaving the Resort, see a doctor right away and advise the Resort.* All guests shall further acknowledge and agree that they are fully aware of the contagious nature and effects of COVID-19 and voluntarily assume that risk and responsibility and further agree that they will release, indemnify and hold harmless Unique Travel Corp, the designated resort and Sandals Resorts International Limited, and their respective parent companies, affiliates, subsidiaries, insurers, directors, officers, employees, successors, assigns, agents and representatives, against any claims and/or damages whatsoever, including legal fees relating to any infection, transmission, health condition influenced or otherwise impacted or complication by COVID-19.

Travel Safety Warning

- (a) Due to the fact that travel and tourism are constantly in a state of flux, prizewinner is advised to consult the U.S. State Department's website at travel.gov and enter the name of the country(ies) that they plan to visit for the latest information concerning traveler safety, security, and health advisories.
